PHYSICAL CHARACTERISTICS:

Color: Blue

Form: 0.1 % w/v suspension of Streptavidin Coated Fluorescent Blue Particles in Isotonic Buffered Saline with 0.02% Sodium Azide as preservative.

PHYSICAL HAZARDS: This product is not a flammable liquid as supplied; however, the solid contents are combustible when dry. Sodium Azide can react with copper and lead in plumbing to form explosive metal azides. If disposed down the drain, flush the drain with copious amounts of water.

Firefighting methods: In case of fire, use carbon dioxide or dry chemical extinguishers.

SPECIAL STORAGE CONDITIONS: Store at 2 to 8 °C. Protect from direct light.

HEALTH HAZARDS: To the best of our knowledge, the health hazards of this product have not been thoroughly investigated.

SAFETY PRECAUTIONS AND CONTROL MEASURES: Potentially harmful if ingested.
